NMCCL COVID-19 Visitor Guidelines – Effective April 19, 2022

Naval Medical Center Camp Lejeune (NMCCL) will allow two (2) healthy visitors per patient.

The visitor(s) will be the only person(s) permitted to visit that patient. View exceptions below.

If the patient has COVID-19 or may have been exposed to COVID-19, <u>no visitors</u> are permitted unless the patient is:

- At the end of life or with cognitive/safety concerns.
- Eligible for a visitor based on a special exception reviewed by their treating provider or charge nurse.

In all other areas of the Medical Center, please note:

- Visitors must be healthy, with no symptoms of COVID-19.
- Properly wear a mask at all times (beneficiaries ages 2 years and older).
- Visitors may be asked to stay in waiting area during procedures or may be asked to step out of exam rooms for portions of an exam/interview at the provider's discretion.*
